Pursuant to Article 28 of the Bylaws of the School of Dental Medicine and the Articles 72 and 73 of the Bylaws of the University in Zagreb, Faculty Council of the School of Dental Medicine at the University of Zagreb on its 1st session held on October 22nd, 2015, passed the following

DECISION
on
the exam order of the program links
regarding the integrated undergraduate and graduate university studies of Dental Medicine
in the academic year 2015/2016

I

Prerequisites for enrolment/exams in subjects regarding the integrated undergraduate and graduate university studies of Dental Medicine in the academic year 2015/16 are:
The passed Chemistry exam is a requirement for taking the Biochemistry exam.
The passed exam in General Pharmacology is a requirement for enrolment (and taking the exam) in Dental Pharmacology.
The passed exam in General Radiology is a requirement for taking the exam in Dental Radiology.
The passed exam in Preclinical and Laboratory Fixed Prosthodontics is a requirement for enrolment (and taking the exam) in Fixed Prosthodontics I.
The passed exam in Preclinical and Laboratory Removable Prosthodontics is a requirement for enrolment (and taking the exam) in Removable Prosthodontics I.
The passed exam in Preclinical Restorative Dentistry is a requirement for enrolment (and taking the exam) in Restorative Dentistry I.
The passed exam in Preclinical Oral Surgery is a requirement for enrolment (and taking the exam) in Oral Surgery I.
The passed exam in Preclinical Periodontology is a requirement for enrolment (and taking exam) in Periodontology I.
The passed exam in Preclinical Endodontics is a requirement for enrolment (and taking the exam) in Endodontics I.
The passed exam in Fixed Prosthodontics I is a requirement for enrolment (and taking exam) in Fixed Prosthodontics II.
The passed exam in Removable Prosthodontics I is a requirement for enrolment (and taking the exam) in Removable Prosthodontics II.
The passed exam in Restorative Dentistry I is a requirement for enrolment (and taking the exam) in Restorative Dentistry II.
The passed exam in Paediatric and Preventive Dentistry I is a requirement for enrolment (and taking the exam) in Paediatric and Preventive Dentistry II.
The passed colloquium in Propaedeutics of Paediatric Dentistry is a requirement for admission to the clinical exercises of Paediatric and Preventive Dentistry I.
The passed exam in Oral Surgery I is a requirement for enrolment (and taking the exam) in Oral Surgery II.
The passed exam in Endodontics I is a requirement for enrolment (and taking the exam) in Endodontics II.



The passed exam in Oral Medicine I is a requirement for enrolment (and taking the exam) in Oral Medicine II.

The passed exam in Preclinical Orthodontics is a requirement for enrolment (and taking the exam) in Orthodontics.

II

For enrolment in the next year of studies it is necessary to acquire 55 ECTS credit points. For enrolment in the third year of studies it is necessary to pass all exams from the first year of studies.

For enrolment in the fourth year of studies it is necessary to pass all exams from the second year of studies.

For enrolment in the fifth year of studies it is necessary to pass all exams from the third year of studies.

For enrolment in the sixth year of studies it is necessary to pass all exams from the fourth year of studies.

III

In accordance with Article 71 para. 4 of the Bylaws of the University in Zagreb, the student can present himself for an exam in the same subject four times at most. The fourth time he has to take the exam in front of a board of examiners.

A student who did not pass the exam in the same subject for the fourth time is obliged to enrol this subject again in the next academic year.

If, after re-enrolment of the same subject, the student does not take the exam in this subject as determined in Article 71 para. 4 of the Bylaws, he will forfeit the right to study.

In accordance with Article 14 of the Study Rules for undergraduate and graduate studies, and Article 60 of the Bylaws of the University in Zagreb, a student who does not acquire at least 35 ECTS credit points during two consecutive academic years, will lose his student status.

IV

This Decision comes into force on the day of publication and shall apply from October 22nd, 2015. The conclusion on the exam order, passed on the 25th session of the Faculty Council dated September 24th, 2015, ceases to be valid.
